Tactical portfolios seek to optimize returns over a shorter time horizon than other portfolios we manage.

Depending on market conditions and prevailing opportunities, more tactical managers may be utilized.

These managers may have greater flexibility to overweight certain asset classes according to market conditions compared to other, more traditional, allocation models.

These portfolios may be preferable for investors who pursue a strategy that actively adjusts asset allocations.

This specific model is designed with a goal of providing capital appreciation potential, limited income, and appropriate diversification among asset classes.

PORTFOLIO POSITIONING

The portfolio primarily consists of tactical managers, who may be more defensive in difficult markets and more opportunistic in favorable markets.

The equity portion of the portfolio, compared to the benchmark, had overweight exposure in the following sectors:

- Materials
- Financials
- Real Estate
- Industrials
- Healthcare


It was underweight in the following sectors:

- Utilities


At month-end, the equity style breakdown was 68% large cap, and 32% Mid-Small Cap.

The Bond Credit Rating breakdown was 90% Investment Grade and 10% High-Yield Bonds.

PERFORMANCE REVIEW

Year-to-date, the portfolio's total return is 15.94% gross of fees, and 14.81% net of an average fee.

For the trailing five years, the portfolio's total return is 9.13% gross of fees, and 7.98% net of an average fee.

6 of 11 sectors positively impacted performance on an absolute basis in this quarter, with the Materials, Consumer Discretionary, Communication, Technology, and Healthcare detracting.

The benchmarks were selected because, in our opinion, they most closely track the types of holdings that are likely to be included in our allocations.

The custom benchmark uses a 51.94% Large Blend, 16.66% Foreign Large Blend, 29.40% Int Bond, and 2.00% Cash rebalanced monthly. The index return is calculated by weighting the respective index return on a monthly basis.

The Large Blend represents The Morningstar US Fund Large Blend Category which includes large-blend fund portfolios which are fairly representative of the overall U.S. stock market in size, growth rates, and price. Stocks in the top 70% of the capitalization of the U.S. equity market are defined as large cap. The blend style is assigned to portfolios where neither growth nor value characteristics predominate. These portfolios tend to invest across the spectrum of U.S. industries, and owing to their broad exposure, the portfolios' returns are often similar to those of the S&P 500 Index. The Foreign Large Blend reprents the Morningstar US Fund Foreign Large Blend Category which includes foreign large-blend fund portfolios which invest in a variety of big international stocks. These portfolios primarily invest in stocks that have market caps in the top 70% of each economically integrated. The blend style is assigned to portfolios where neither growth nor value characteristics predominate. These portfolios typically will have less than 20% of assets invested in U.S. stocks. The Int Bond represents the Morningstar US Fund Intermediate Core Bond which includes fund portfolios that focus on corporate, government, foreign or other issues with an average duration of greater than or equal to 3.5 years but less than or equal to 6 years, or an average effective maturity of more than 4 years but less than 10 years.
